Active Members are entitled to 1 vote on each matter, each respectively, and may be elected as an officer or board member of the Association. Dues: \$35 per year.

Affiliate membership may be extended to spouse and/or employees of Active Members or Associate Member. Affiliate Members enjoy the benefits afforded Active and Associate Members, but have no voting rights and may not be elected as an officer or board member of the Association. Dues: \$5 per year.

Associate membership is open to any person who owns and operates a business outside of West Virginia to grow and/or sell ornamental nursery stock and/or provide services to the nursery and landscape industry. West Virginia superintendents of parks and estates, public gardens, and arboretums; horticulture educators; and officials with the West Virginia Department of Agriculture may also apply to be Associate Members. Associate Members have no voting rights and may not be elected as an officer or board member of the Association. Dues: \$35 per year.

Individual Professional membership is any person who is professionally engaged in the horticulture industry, or anyone who has retired from a professional nursery and/or landscape position. These members are entitled to 1 vote on each matter, each respectively, and may be elected as an officer or board member of the Association. Dues: \$35 per year

Student membership is open to any individual student currently enrolled in a horticultural or landscape program in high school or college in West Virginia. Student members have no voting rights and may not be elected as an officer or board member of the Association. Dues \$25 per year.

Allied membership is open to national, regional and/or local merchandisers with at least 25% of their gross sales in green goods and year-round sales facilities for nursery stock. Representatives of these firms have no voting rights, may not hold office or be eligible for membership on the Board of Directors. Each store will be counted as one allied member. Dues: \$100 per store, per year.
