Hot Off The Press: Landscape Plants for West Virginia



WVNLA Announces \$25,000 in 2025 Scholarships to Landscape Architecture and Horticulture Students


Five in-state students attending West Virginia University (WVU) studying landscape architecture and horticulture are receiving \$5,000 each, thanks to WVNLA's Marcus W. Rennix scholarship program. The WVNLA scholarship fund was created in 1986. The first award was \$1,000 and given to one recipient in 1987.

The WVU scholars will be recognized at the

reapplying. Competition was high this year, with an abundance of applicants, which challenged board



members to make their selections.

The criteria prioritizes scholarships to West Virginia citizens wherever they are studying in an effort to support the nursery and landscape industry in West Virginia. The Marcus W. Rennix scholarship applications are accepted annually via the WVNLA

website through Sept. 30. Applicants seeking scholarship funding must be studying horticulture, landscape architecture, or nursery and greenhouse management. Students must be in-state residents who have completed half the required courses in ornamental horticulture or landscape architecture and maintained at least a 2.5 grade point average.

<u>Have You Filed?</u> Corporate Transparency Act Deadline Looms

The Corporate Transparency Act, which went into effect in January 2024, may require your small business to report information about ownership to the government. Under the act, many U.S. small business owners are required to file corporate transparency reports with beneficial ownership information.

For most eligible businesses, the filing deadline is January 1, 2025. Those who fail to file by this deadline — or fail to update this information if needed — could face up to two years imprisonment and fines up to \$10,000, in addition to civil penalties of up to \$591 per day.

What is the Corporate Transparency Act?

The CTA was enacted in 2021 to combat illicit activity including tax fraud, money laundering, and financing for terrorism by capturing more

ownership information for specific U.S. businesses operating in or accessing the country's market. Under the new legislation, businesses that meet certain criteria must submit a Beneficial **Ownership Information** (BOI) Report to the U.S. Department of Treasury's **Financial** Crimes Enforcement Network (FinCEN). This report provides details identifying individuals who are associated with the reporting company.

The CTA was established to prevent individuals with malicious intent from hiding or benefitting from the ownership of their U.S. entities to facilitate illegal operations which, according to Congress, is a widely-used tactic that affects national security and economic integrity.

Who is considered a beneficial owner of a company?

According to the CTA, an individual qualifies as a beneficial owner if they directly or indirectly have a significant ownership stake in a company. This person either has a major influence on the reporting company's decisions or operations, owns at least 25% of the company's shares, or has a similar level of control over the company's equity.

What information must be reported about a

company's beneficial owners?

All reporting companies must provide their legal name and trademarks, as well as their current U.S. address, which could be either the address of its main business site or, for foreign-based companies, their U.S. operational location. They'll also need to provide a taxpayer identification number and specify the jurisdiction where they were formed or registered.

Businesses registered or established post-January 1, 2024, must provide information regarding the business, its beneficial owners, and its company applicants — including owners' and applicants' names, addresses, birthdays, and identification numbers (such as a license or passport number), and the jurisdiction of the documents. Businesses established before that date



can omit information regarding company applicants, and must only submit information on the business and beneficial owners.

While the CTA does not require businesses to submit annual reports, the initial filing period may not be the only time you'll be required to submit information.

"In addition to the required initial filing, there are requirements to update the original filing when

things change," explained Roger Harris, President of Padgett Business Services. "Some of the things that require an updated filing are not things a business owner has ever thought were important to track, and the timeline to report these changes can be as short as 30 days."

Harris noted that business owners may be surprised by some requirements for updated filings. For instance, if a beneficial owner changes their address, legally changes their name due to marriage or divorce, or obtains a new driver's license, it may necessitate an update to a company's BOI report. Operational changes or a new delegation of authority could also qualify.

Board Members Tour Newly Installed Entrance at the WV Botanic Garden

Following the completion of a major paving project late last year, the West Virginia Botanic Garden (WVBG) shifted its focus to enhancing the main entry near the new Visitors Center. Phil Cole, site manager and designer at WVBG presented several case studies and concepts to the garden's planning committee.

The committee pulled together different elements they wanted to see highlighted in the new entry design, which included native sandstone

accent walls, accentuated beds with bold colors, textures and evergreens. WVBG presented the plans and budget to the West Virginia Nursery & Landscaping Association whose board members voted to provide all the funding for the project.

The entry design consists of a series of circular stone garden walls that provide elevated landscapes on

both sides of the entrance. The existing sign was raised and pushed closer to the road. A rotating selection of annuals will dominate the lower front borders.

The beds within the walls have sweeping drifts of warm season grasses like purple lovegrass, *Eragrostis spectabilis*, and colorful perennials including giant hyssop, *Agastache*; both new plants to WVBG. The landscape is punctuated with boulders and unique conifers, including a Limber pine, *Pinus flexilis 'Vanderwolf's Pyramid'* and the regionally named Canaan Fir or West Virginia



Balsam, *Abies balsamea subsp. Phanerolepis;* a true native tree to West Virginia. The tree, donated by

Jim and Laura Rockis of Morgantown, is a stately focal point directly next to the entry sign.

Originally found in the Canaan Valley, these special firs have an interesting history and are becoming more popular in the Christmas tree trade due to their tidy appearance and adaptability to a wide range of soils and environments.

The earthwork, planting and lighting was installed by WVBG staff members and volunteers this fall.

be considered to give a new person substantial control of your business, you could be required to update your filings, even if the person performing those duties did not own any of the business," said Harris.

What is the beneficial ownership information reporting process?

Reporting companies have a limited time to file their initial BOI reports:

- For qualifying reporting companies established before the above date, the filing deadline is January 1, 2025.
- Those created between January 1, 2024,

and January 1, 2025, will have 90 days from either the actual notice of formation or public announcement, whichever comes first, to file.

• Businesses established on or after January 1, 2025, will have 30 days from notification or public announcement of their formation to submit their first report to FinCEN.

• Businesses must submit any corrections or updates to previously filed information within 30 days.

Businesses will not incur a fee for submitting their reports, and electronic forms are available on FinCEN's website: https://www.fincen.gov/boi.

Grow This! Throwdown Challenges West Virginians to Grow Vegetables and Enjoy a More Healthy Lifestyle

Earlier this year, WVNLA received a funding request to sponsor an award in the WVU Extension Service's wildly successful Grow This! Throwdown 2024. Our board of directors voted to sponsor the third-place prize of \$5,000. The winning county extension office receives the award to use toward a community project.

Started in 2018, the Grow This: West Virginia Garden Challenge's concept was simple. Many West Virginians live in food deserts with limited access to fresh fruits and vegetables. This program aimed to partially close that gap by encouraging families to grow their own food, through providing free seeds and gardening education. The program aimed to get West Virginians to move more, grow their own food and decrease hunger in the state.

For the first few years, only a few hundred participants signed up. But interest exploded in 2020 as COVID lockdowns left many West Virginians stuck at home, looking for a new hobby and worried about food supply chains. Participants requested and received seeds. The 2024 seeds were scarlet Nantes carrots, red Russian kale and Jimmy Nardello peppers. More than 90,000 people participated in the 2024 competition, which awarded counties points for participants' production, activities and produce donations.

The competition was spirited. The winning counties were announced on Nov. 14.

First place (\$10,000) went to Preston County. Second place (\$7,500) went to Pocahontas

County.

Third place (\$5,000) went to Berkeley County.

WVNLA president Bobby Gompers was on hand to present the check to a very enthusiastic group of third place winners in Martinsburg.

Highlights of Berkeley County's accomplishments include:

- starting four new seed libraries in their county,
- reporting 138 pounds of freshly harvested produce, and
- creating an edible landscape at the Martinsburg Garden of Promise.

The 2024 competition has concluded, but the folks at Grow This! Throwdown encourage everyone to get involved in 2025. "If you'd like to get involved in the Grow This! Throwdown next year, just make sure you're following us on Facebook and on Instagram (@growthiswv). There will be more grant funding up for grabs next year, and you can help your county climb its way to the top," they say.
